From the Pastor's Study...

"Winds in the east, mist coming in. Like somethin' is brewin' and 'bout to begin. Can't put me finger on what lies in store, but I fear what's to happen all happened before." -Bert, Mary Poppins 1964

Many of us remember the first time we watched Mary Poppins fly to 17 Cherry-Tree Lane and into the Banks family heart. We watched as she proved that a "spoonful of sugar" does indeed make the medicine go down easier and that if you put enough elbow grease and imagination into life, extraordinary things happen. You fought against Satan's attack to divide and destroy harmony at the beginning — you went through painful, heart-wrenching work — but you have come out on the other side united, a band of brothers and sisters who have each other's back and an eye on God's eternal prize for his Bride the church. Never forget your first love. You play to an audience of One — continue to discern his mind alone and you will never take the church from its mission or out of His glory.

Thank you to the staff. For such a time as this you were chosen. Your ministry is important at Providence, and I do not mean the work people see on Sunday morning alone. Your ministry lies in your relationship with each other, the congregation and your relationship with the Lord. Thank you for experimenting with ministry opportunities that COVID gave us. My prayer is that God continues knitting you together with the installed pastor.

Don't be afraid to try new things and follow their leadership. Remember you trusted them enough to elect them and hire them; trust them enough to lead you into God's glorious ministry.



Providence Presbyterian Church Minutes of Stated Session Meeting June 14, 2021

Providence Presbyterian Church conducted a Stated Session Meeting on June 14, 2021 at 7:00pm at the church. The Elders present were: Vickie Faircloth, Kristy Stephenson, Donna Stolle, John Kopanski, Scott Martin, John Pickens, Sam Stephenson, and Kent Walton. Elder John Mott was excused. Also in attendance, was David Collier, Chairperson of the Pastor Nominating Committee ("PNC"). Pastor Nadia Stropich served as moderator. Pastor Nadia declared that a quorum was present and opened the meeting with prayer. The devotional was presented by Vickie Faircloth.

Review of Minutes and Omnibus Committee Reports

The minutes of the May 10, 2021 Stated Session Meeting, the minutes of the May 16, 2021 Called Session Meeting and the omnibus committee reports were reviewed by the Session. Committees that have not meet were: Christian Education, Finance, Long-Range Planning, Personnel, and Property. John Kopanski made a motion to approve the minutes of the May 10, 2021 Stated Session Meeting and the minutes of the May 16, 2021 Called Session Meeting. The motion was seconded. The Session voted and the motion was approved.

Scott Martin made a motion to approve the June 14, 2021 Stated Session Meeting agenda and the omnibus committee reports. The motion was seconded by Kent Walton. The Session voted and the motion was approved.

Pastor Nominating Committee ("PNC")

Pastor Nominating Committee Chairperson, David Collier, provided the Session with a status report on behalf of the PNC. David conveyed that the committee is evaluating Pastor Information Forms of potential candidates. The process will continue as the committee seeks God's will for the Providence Church family. After his report, Mr. Collier excused himself from the meeting.

Report from the Presbytery Gathering

Pastor Nadia conveyed that she attended the Presbytery of the Mid-Atlantic ("PMA") Coastal Region gathering conducted on May 22, 2021 at Englewood Presbyterian Church in Rocky Mount, NC. Pastor Nadia indicated that the PMA Coastal Region is asking churches to strongly consider increasing their per member giving by twenty (25) percent in 2022. In addition, PMA Coastal Region is seeking Teaching Elders, Ruling Elders, and other church leaders to serve on committees.

Financial Report

Sam Stephenson reviewed the May 2021 financial report and provided the following information:

- Mortgage balance is \$620,273.54. Money Market savings balance is \$85,969.74.
- Bank Checking Account balance is \$96,217.03.
- Designated Fund book balance is \$84,089.14 and the General Fund book balance is \$11,698.45.

- Cemetery CD was renewed
- Budgeted EPC member asking donations of close to \$8,000 are budgeted.
- The Homecoming designated fund balance is \$27,939.50

Sam also provided the following donation summary from sources as follows:

- Stock Sales: \$11,605.08
- Undesignated donation in the amount of: \$5,000.00
- Interest from CD: \$89.26

Donation total: **\$16,694.34** (This amount is currently being held in escrow in the General Fund). Sam indicated that if needed, the undesignated donations in part or in full could be used towards meeting the matching donation to pay off the PCUSA dismissal fee.

Sam made a motion to approve the financial report for May 2021. The Session voted and the motion was approved.

With regards to the donation summary, John Pickens presented the following motion: At the next Session Meeting (July 12, 2021), review the amount of donations received towards the Capital Campaign for matching donor PCUSA dismissal fee. Allocate a portion or all of the \$16,694.34 towards meeting the Capital Campaign for matching donor PCUSA dismissal fee. The motion was seconded by Donna Stolle. The Session voted and the motion was approved.

Old Business

Website and Policy Book Review

At the last Stated Session Meeting, Pastor Nadia asked the Session to provide any website or policy book revisions pertinent to each Chairperson's committee. It was determined that the Session needed additional time to prepare; thus, the item was tabled and will be presented at a future meeting.

Mission Statement

Related to policy revisions, Pastor Nadia indicated that since the Session approved a new mission statement for the church and it is part of the Articles of Incorporation, a corporation meeting would be needed to approve the new mission statement. It was determined that with proper congregational notice, the corporation meeting would be conducted on June 27, 2021. Donna Stolle made a motion to conduct the corporation meeting on June 27, 2021 for the stated purpose of approving the church's new mission statement. The motion was seconded by John Kopanski. The Session voted and the motion was approved.

*Update: Pastor Nadia emailed the Session on June 14, 2021 (about an hour after the Session Meeting was adjourned) to convey that after further review of the Articles of Incorporation, that the church's mission statement is not part of the Articles of Incorporation. Thus, the congregation does not have to vote to approve the new mission statement. Therefore, the motion to conduct a corporation meeting for said purpose is hereby revoked. However, Pastor Nadia informed the Session that it would be wise to inform the congregation about the church's new mission statement. Thus, Pastor Nadia will inform the congregation about the new mission statement during the worship service on June 20, 2021.

Worship: Discussion on Meeting Space for Worship Services

The Session resumed discussion on worship space options. The discussion on this matter began at the Stated Session Meeting conducted on May 10, 2021. The worship space options previously discussed included the following:

- Continue worship in the Upper Fellowship Hall ("UFH").
- Resume worship in the Sanctuary.
- Combination of both spaces: conducting main worship in the UFH with video transmission to the sanctuary.

Pastor Nadia asked each Session member to share their thoughts and concerns regarding the matter. Many Session members conveyed that they received input from members of the congregation. As well, some Session members solicited input from congregants on their care list.

After thoughtful deliberation, the Session did not reach a definitive determination on the worship space options. Therefore, Pastor Nadia informed the Session that there will be a called Session Meeting on June 21, 2021 at 7:00 pm. The meeting will be dedicated to choosing a worship space option. The meeting will be conducted via Zoom video conference. This is because Pastor Nadia will be in Denver Colorado on study leave.
